#### **Behind the Data**

Bloomberg Government looked at the 2,095 registered lobbying firms that filed Lobbying Disclosure Act reports with the Senate during 2020. This report focuses on lobbying activity of 317 top lobbying firms – those that reported \$1 million or more in revenue in 2020 and lobbying activity in each quarter of 2020\*.

For the sixth consecutive year, Bloomberg Government identified top-performing firms, measured by five critical business performance metrics. The standout firms exhibited growth in revenue and average revenue per client; high short- and long-term customer retention rates; and exceptional revenue per registered lobbyist.

Detailed analysis of fourth-quarter and full-year activity for every registered lobbying firm and lobbying client is currently available on **BGOV.com**.






